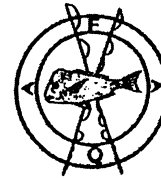

The Annual General Meeting will be held at 9am on Saturday, 1 August 2009 at the cottage.

The AFAQ invites nominations for election to the 2009/10 AFAQ Management Committee. A nomination form was attached to the last newsletter.

There are 8 management committee positions, President, Vice President, Treasurer, Secretary and Cottage Chairman and three committee members.

Nominees for the positions of President, Vice President, Treasurer, Secretary and Cottage Chairman must have established financial membership with the Association for at least two years. Nominees for committee members must have established financial membership with the Association for not less than one year.

The next general meeting will be held at 9:00am **4 July** at the cottage followed by the working bee.

IMPORTANT NOTICE

Cottage Redevelopment and Maintenance Vote

The vote on the cottage redevelopment and maintenance proposals will be held on 4 July 2009 during the general meeting of members beginning 9am on 4 July 2009 at the cottage at Bongaree.

At the last general meeting of members the management committee's proposal was discussed, amended and moved that the matter be voted on during the 4 July general meeting. All proxy forms must be lodged with the Secretary prior to the meeting

The six motions to be put to members are as follows;

Motion 1 (known as Option 6)

Cottage works – Raise and reposition the cottage, reinforce with steel beams and refurbish underneath.

Objective: Level the floor, replace stumps, raise the floor level, rotate the building slightly and move forward to comply with boundaries, concrete floor under cottage, with future fit-out under cottage with change room and toilet, storage, junior members quarters, museum display area, lean to shed.

Conditions: Subject to finances, subject to grant funding, subject to council approval, subject to Heritage council approval if required.

If Motion 1 is carried then Motions 2, 3, 4, 5 and 6 shall be withdrawn

Motion 2 (Management Committee recommendation)

Cottage works – Raise the cottage at its present position, reinforce with steel beams

Objective: Level the floor, replace stumps, raise floor level, and concrete floor under cottage, with the view of progressively fitting out under cottage on an as needs basis (toilet, storage, junior members quarters, museum display area, boat storage).

Conditions: Subject to finances, subject to grant funding, subject to council approval, subject to Heritage council approval if required

If Motion 2 is carried then Motions 3, 4, 5 and 6 shall be withdrawn

Motion 3 (known as Option 4)

Cottage maintenance - level and stabilise the cottage at existing position and height

Objective: Level the floor and replace stumps

Conditions: Subject to finances, subject to council approval, subject to Heritage council approval if required, No grant required, however grants have been provided for this in the past.

If Motion 3 is carried then Motions 4 shall be withdrawn

Motion 4

Cottage maintenance

Objective: The management committee are empowered to and shall implement a program of maintenance immediately.

Conditions: Subject to finances, subject to Heritage council approval if required.

Motion 5 (known as Option 3)

Shed - construction of a large shed fitted with junior quarters, shower toilet and laundry, and remove the existing amenities block and garden shed.

Objective: Remove existing amenities block and caravan, and build a shed to provide new amenities, storage of boat and camping gear and junior quarters.

Conditions: Subject to finances, subject to grant funding, subject to council approval, subject to Heritage council approval if required.

If Motion 5 is carried then Motion 6 shall be withdrawn.

Motion 6 (known as Option 2)

Shed - construction of a large shed next to the amenities block and garden shed.

Objective: Build a shed to provide storage for camping gear and boat.

Conditions: Subject to finances, subject to grant funding, subject to council approval, subject to Heritage council approval if required.
